a. Facility Energy Efficiency Tour – Superintendent Forrest introduced Pepper Gratzner to board members. For the past couple of weeks Mr. Gratzner has been working with the district's facilities supervisor, Ronald Parker to assess various ways to increase the efficiency of the district's heating systems.
